Chairman Dan King called the meeting to order, with all board members present. Jill Cook treasurer was absent.

Clerks report was presented, Ron Peterson made a motion to accept the report. Merle Larson seconded the motion: motion carried.

Treasurers report was presented, Ron Peterson made a motion to accept the report. Merle Larson seconded the motion: motion carried.

Bob Pardun accessor stated that the town has been out of compliance for 4 years which is the window allowed. Next year the town will need to be reassessed to stay in compliance. Merle Larson made a motion to accept Bob Pardun accessor to complete the new assessment as required. Ron Peterson seconded the motion: motion carried.

Road bids were opened and discussed. Merle Larson made a motion to approve the bid from Fahrner on crack filling for \$99,759.00. Ron Peterson seconded the motion: motion carried.

Merle Larson made a motion to accept a bid from Fahrner to cheap seal a portion of 220<sup>th</sup> st from Hwy N to 270<sup>th</sup> Ave. for \$48,189.00. Ron Peterson seconded the motion: motion carried.  
Work on 220th st should start mid-August.

Merle Larson made a motion to accept a bid form Monarh paving for patching various spots on 228<sup>th</sup> st and 234<sup>th</sup> st. for \$15,544.00. Ron Peterson seconded the motion: motion carried.

Sam Gudmonson from Cushing Cemetery spoke requesting that the town plow out the cemetery in the winter for funerals. It was discussed and from a prior motion that passed. The town will plow the cemetery out when there is a funeral in the winter.

Emails for town supervisors was discussed and they will move forward establishing individual emails. Once that is complete, they will be listed on the towns website.

Discussion on the hours of operation for the Mathy mine was discussed. At this time it is not a town board item. The hours of operation were set between Mathy and a group of individuals from Laketown and any change in those hours would need to be between those parties involved.

Road report was given by Chris Bartlett. Looking to get the 1 ton back from the repair shop soon. Chris has completed all ditch mowing in the town for the first cutting. Chris has been working on ditching on 225<sup>th</sup> st. Chris will continue patching spots so it will be ready for the upcoming road repairs. Chris is planning on doing additional grading once we get some rain. Work continues with the county on new fire numbers as everyone is required to have one. Shop plans are moving along, and Chris is working on getting some estimates and quotes for that. Chris will be purchasing culverts and will continue to work on the culvert on Sand Lake.

Correspondence was review and bills were presented for approval.
